RE: JOINT OBSTRUCTION OF FUNDS ARRIVED 13 MARCH 2026

1. DECLARATION OF COLLECTIVE COMPLICITY

You are hereby addressed as a unified block of obstruction. The following MT103 transfers arrived at your nodes on 13 MARCH 2026. Your joint silence since 17/18 MARCH 2026 is now formally recorded as Silent Consent and Collective Complicity:

2. SOVEREIGN FINES & UNIVERSAL LIABILITY

Thailand Sovereign Fine: \$8,000,000,000.00 USD (\$8 Billion) for the country's complicity in blocking the Universal Pool.
